- 2. It was discussed that students should be informed about the consequences of violating the rules in case of sexual harassment in the college premises in the seminar organised.
- 3. The committee noted that no complaint of sexual harassment has been received from any women employee of its department.
- 4. The Chairperson conveyed her thanks to the members for attending the meeting.
 - 5. The meeting ended with the vote of thanks to the chair.
